In an effort to ensure a successful implementation of Enterprise Justice/Odyssey systems, the following capacity limits shall be placed on criminal court sessions beginning July 16, 2025 as follows:

DISTRICT CRIMINAL COURT

July 16-18, 2025: Mandatory courts will be held; these include:

- CR 205: First Appearances
- CR 203: Juvenile Court mandatory matters
- CR 308: Preliminary Court mandatory matters (first preliminary court date)

All other district criminal courts will not be held during this time period.

July 21 – August 29, 2025: All criminal district courts will be held pursuant to the following capacity limits:

- CR 102 (Traffic), 201 (Criminal), 203 (Juvenile), 208 (Criminal Domestic), 308 (Preliminary Court): **Capacity Limit of 50**
- Kernersville Court: **Capacity Limit of 30**
- CR 205 (First Appearances): mandatory first appearances shall proceed without capacity limit; there shall be no matters added on other than mandatory first appearances.

September 2 – October 10, 2025: All criminal district courts will be held pursuant to the following capacity limits:

- CR 102 (Traffic), 201 (Criminal), 203 (Juvenile), 208 (Criminal Domestic), 308 (Preliminary Court): **Capacity Limit of 100**
- Kernersville Court: **Capacity Limit of 60**
- CR 205 (First Appearances): mandatory first appearances shall proceed without capacity limit; there shall be no matters added on other than mandatory first appearances.

October 13 – November 21, 2025: All criminal district courts will be held pursuant to the following capacity limits:

- CR 102 (Traffic), 201 (Criminal), 203 (Juvenile), 208 (Criminal Domestic), 308 (Preliminary Court): **Capacity Limit of 150**
- Kernersville Court: **Capacity Limit of 90**
- CR 205 (First Appearances): mandatory first appearances shall proceed without capacity limit; there shall be no matters added on other than mandatory first appearances.

SUPERIOR CRIMINAL COURT

July 16-18, 2025: No changes


July 21 – September 19, 2025: Criminal superior courts will be held pursuant to the following capacity limits:

- Felony trial sessions: **Capacity Limit of 100**
- Misdemeanor Appeal Arraignment Docket: **Capacity Limit of 100**
- Misdemeanor Appeal Trial Docket: **Capacity Limit of 100**
- Probation Violation H&I Docket: **Capacity Limit of 100**
- Probation Violation Superior Court Docket: **Capacity Limit of 100**
- Administrative Court First Setting Docket: **Capacity Limit of 300**
- Administrative Court Second Setting Docket: **Capacity Limit of 300**
- Administrative Court No Rep Docket: **Capacity Limit of 300**


IT IS THEREFORE ORDERED that the Clerk of Superior Court for Forsyth County, as well as the Magistrates and other calendaring authorities, are limited to the maximum number of defendants/juveniles on each calendar for each court type, excluding add-on cases as allowed by the presiding judge, as set forth within this order from July 16 through September 19, 2025.

IT IS FURTHER ORDERED that to effectuate the purpose and intent of this Order the Clerk of Superior Court for Forsyth County is authorized and empowered to maintain the integrity of the above capacity limits by removing the newest cases added to a calendar which are over the capacity limit and re-calendaring each case removed, in consultation with the District Attorney's Office, to the next appropriate court date (excluding add-on cases as allowed by the presiding judge).
