Reclassification of Case Files to “For Recorded” and “Closed” Status

Now comes the Court, by and through the Chief District Court Judge of the 18th Judicial District, Guilford County, and finds that in the interest of justice and in accordance with North Carolina General Statute 7A-146, in preparation for E-Courts, the Clerk of Superior Court should designate civil cases pending since 2010 or earlier, and have remained inactive since that time, to be listed as RE (for recorded) in order for the cases to be placed in “closed” status. These cases shall remain in “closed” status until and unless a litigant submits a request to reactivate the file.

It is hereby ordered pursuant to the Court’s inherent authority and statutory authority for the Clerk of Superior Court to designate civil cases pending since 2010 or earlier, and have remained inactive since that time, to be listed as RE (for recorded) in order for the cases to be placed in “closed” status.
