
ORDER DIRECTING AND AUTHORIZING THE MAGISTRATE DIVISION TO ACCEPT FOR FILING JUVENILE DELINQUENCY PETITIONS AND ORDERS FOR SECURE CUSTODY WHEN THE CLERK'S OFFICE IS NOT OPEN OR THE COURT IS CLOSED FOR BUSINESS

Now, pursuant to N.C.G.S. Chapter 7B-1804, the undersigned Chief District Court Judge hereby directs and authorizes the Magistrate Division, and any Magistrate, when the Clerk's Office is not open or the court is closed for business, to accept for filing a juvenile delinquency petition presented by a Juvenile Court Counselor. The Magistrate is further authorized to accept for filing any secure custody order obtained as a result of the filed petition(s). That the magistrate is authorized to date and time stamp for filing, to administer an oath as necessary and to verify the Petition and any supporting documents or affidavits presented with the juvenile petition. The Juvenile Court Counselor will call the on-call Judge to request the secure custody order once the Petition is accepted by the Magistrate for filing.

The Magistrate shall keep the petition and any documents related to the Juvenile case in a separate folder or large envelope marked confidential.

That the Magistrate shall deliver the Petition and any related documents to the Clerk as soon as the Clerk's office is open for processing and shall provide to the Clerk the date and time the Petition was received and the secure custody order was entered for notation in the Court file pursuant to 7B-1804(b).

**ADMINISTRATIVE ORDER**

ORDER AUTHORIZING THE MAGISTRATE DIVISION  
TO ACCEPT FOR FILING JUVENILE PETITIONS AND ISSUE AN  
ORDER FOR NONSECURE CUSTODY AS THE JUDGE'S DESIGNEE  
WHEN THE CLERK'S OFFICE IS NOT OPEN OR THE COURT IS CLOSED FOR BUSINESS

Now, pursuant to N.C.G.S. Chapter 7B-404 and 7B-502, the undersigned Chief District Court Judge hereby delegates and authorizes the Magistrate Division, and any Magistrate, when the Clerk's Office is not open or the court is closed for business, to accept for filing a juvenile petition presented by the Cumberland County Department of Social Services Director or any social worker acting on behalf of the Director. That the magistrate is authorized to date and time stamp for filing, to administer an oath of the social worker and to verify the Petition and any supporting documents or affidavits presented with the juvenile petition.

That the Magistrate Division is, pursuant to said Statutes, authorized to enter a nonsecure custody order, as the judge's designee, in consultation with the on call Judge, granting nonsecure custody to the Cumberland County Department of Social Services, as provided by Chapter 7B.

The Magistrate shall keep the petition, the nonsecure custody order and any documents related to the Juvenile case in a separate folder or large envelope marked confidential.

That the Magistrate shall deliver the Petition, the nonsecure custody order and any related documents to the Clerk as soon as the Clerk's office is open for processing and shall provide to the Clerk the date and time the Petition was received and the nonsecure custody order was entered for notation in the Court file pursuant to 7B-404 and 7B-405.

This order supersedes the Administrative Order entered February 13, 2019.
